CORRESPONDENCE:

- 1. A letter dated October 13, 2023 from Boswell Engineering to the Authority regarding legal notification of an application to the NJDEP for a Flood Hazard Area individual permit. The application is regarding the redevelopment of the Passaic County Department of Public Works site into senior citizen housing and salt storage facility.
- 2. A letter dated October 17, 2023 from Jefferey M. Kassover to Mr. Robert Benecke regarding the Pompton Plaza's complaint for the request for a capacity study by the Authority. Mr. Kassover advised Mr. Bencke the Authority's wastewater treatment plant and its sewerage pumping stations are not of unlimited capacity. The Authority cannot issue a "will serve" letter based upon the information that has thus far been provided.
- A letter dated October 17, 2023 from Jeffrey M. Kassover to Chemtrade Chemicals US LLC regarding Contract No. Chem 23-25 Furnishing and Delivering Liquid Aluminum Sulfate Term: 11/1/23 – 10/31/25. Enclosed is a fully executed contract.
