In Mr. Decker reported progress and noted that the Solar Project is still under discussion. A Request For Qualifications has been prepared by Siemens which Mr. Kassover has reviewed. Mr. Kassover will prepare a revised agreement for publication.

Mr. Decker reported that, as requested, Councilman Kent looked into the two lots adjacent to WGHT for possible solar sites. Councilman Kent informed him that the one lot is designated as Open Space but the other lot directly behind WGHT which is nine acres and is borough property could be considered for a solar site.

Mr. Carroll inquired if Siemens has given the Authority a timeline for the Solar Project. Mr. Decker stated that he has requested a timeline from Siemens and noted that there is another vendor, Protech Energy Solutions which is interested in this project and the Authority is not obligated to use Siemens. Mr. Carroll then said not so much a time line but a road map. Mr. Decker will pursue.

Mr. Decker also reported that Alaimo Engineering has submitted new drawings and recommendations on the Twin Lakes Dam. The documents have been reviewed and the Authority is pleased with rehabilitation plan for the dam. Plans are to be submitted to the NJDEP in June.

WATER OPERATIONS:

Mr. Wegele reported that the leak detection survey has been completed and three major leaks have been detected and repaired. One was on Colfax Avenue, the second on Cannonball Road and the third on Lenox Avenue. Mr. Wegele reported that in addition there are two minor leaks at hydrants, one is located on Garden Road section and the other one is on Hamburg Turnpike.
