PERSONNEL:

Mr. DeMaio reported progress

EXECUTIVE DIRECTOR/FACILITIES REPORT:

Mr. Decker reported we are proceeding with an application to the Wastewater Trust Program for the WWTP Clarifier Rehabilitation. Mr. Decker also noted that the Authority will be starting the WWTP Sludge Holding Tank Mixer Projects at the beginning of next fiscal year.

WATER OPERATIONS:

Mr. Galletta submitted Mr. Wegele's water report and noted there were standard service calls throughout the month.

Mr. Galletta inquired about the Washington Building changing their water service. Mr. Wegele stated that during an emergency call out it was discovered that someone had teed off the water line. The owner was informed that they have thirty days to remove the illegal tee connection. The illegal line was not connected at the time of the discovery.

Mr. Galletta also inquired about a request of an additional meter for a separate water line at 322B Wanaque Avenue. Mr. Wegele stated that a new catering/deli would like to have a separate bill so they split the line and requested to have their own water meter installed. This change was approved by the owner of the building.

Mr. Galletta noted that as of January water consumption is down by 7.9% but up 6.3% compared to 2013. Mr. Galletta noted that in the coming months Mr. Wegele and Ms. Shortway are going to look at billing versus usage and how that ties in. Mr. Galletta noted that more water was pumped last year than any year since 2009. Mr. Wegele stated that water pumped differs from water delivered which is common due to leaks and other factors in the system. The Authority located and repaired 95% of the leaks in the system during the last several months.

SEWER OPERATIONS:

Mr. Longo submitted Mr. Wegele's Sewer Report and noted regular maintenance.

Mr. Decker reported that there has been several meetings and email discussions with Mr. Wegele, Mr. Kassover, Mr. Black, Mr. DeMaio, Borough personnel and developers regarding the proposed redevelopment of the Pompton Lakes Business District and the concerns the B.I.D has regarding the location and capacity of our sewer line which is located in the west pond hole parking lot in the rear of Wanaque Avenue. Mr. Kassover added that the original easement from 1964 was granted to the borough before the creation of the Authority but in 1965 the borough conveyed to the Authority all of its facilities, plants, wells, easements and sewer lines. Mr. Kassover also noted that until the developers come to the Authority with a solid plan for the redevelopment the Authority cannot make a determination regarding the capacity of the line.

ATTORNEY'S REPORT:

Mr. Kassover discussed the proposed modification to the T-Mobile Tower by Sprint and the fact that he is not exactly sure what they are looking to do. Mr. Decker talked about getting ACF on the phone for a conference call with Mr. Kassover. When it's determined what they want to do Mr. Kassover may need Mr. Black's input.

Mr. Kassover also discussed Contract No.131 the WWTP Clarifier Mechanism Replacement Project. Mr. Purcell filed the application with the NJDEP which is being reviewed. Once the DEP approves the application the Authority can advertise for bids. A resolution was read into the record by Mr. Decker authorizing Mr. Kassover to advertise for the project upon the approval from the NJEIT and the Local Finance Board. Another resolution was adopted authorizing the Authority to submit the application to the Local Finance Board for this project.
