EXECUTIVE DIRECTOR/FACILITIES REPORT:

Mr. Decker reported progress and noted that there will be a bid opening on May 6, 2015 for the sludge mixer. The bids are going out for the Clarifier in May.

Mr. Decker also noted Mr. Black spoke with him about electrical work for the sludge thickener controls.

WATER OPERATIONS:

Mr. Galletta submitted Mr. Wegele’s Water Report and noted standard repairs and that the hydrant flushing starts April 27, 2015.

Mr. Galletta noted that all commissioners should have received a copy of the Annual Water Quality Report. Mr. Wegele stated that the report is available on the Authority’s website as well as copies placed in the Library and Borough Hall. If the customer does not have access to a computer the Authority will mail one.

Mr. Wegele prepared a report for Mr. Galletta that states that we are pumping 11% more water than we are billing. Mr. Galletta explained that some of that water loss is believed to be caused by the water that runs through the chlorine analyzers and some leaks in the system that have not been fixed yet, hydrant flushing and Fire Department drills.

Mr. Kassover reported he is waiting for the approval from the Local Finance Board and NJDEP to go forward on advertising Bids for the Clarifier.

Mr. Kassover reported that he drafted a Developers Agreement and revised it addressing connection fees and payment of fees along with other items for the Lakeside Commons project which was hand delivered by Mr. Wegele. So far they have not responded.
