Mr. Kent submitted Mr. Wegele's Water Report and reported that the Authority completed and electronically submitted the Tri-Annual Lead & Copper Monitoring Results to the NJDEP, Bureau of Water System Engineering as required. All 30 of the Lead & Copper sampling Program analysis were non-detect or well below the mcl. Mr. Kent also noted water pumping last July had a significant jump from the prior months. However, this year to date, pumping is about equal from last year.

## **OLD BUSINESS:**

Chairman Carroll reported on the Water Risk and Resilience Assessment performed by Crew Engineering. Chairman Carroll would like all the commissioners to review the summarized assessment and would like anyone to address any issues they feel needs attention and will discuss them at the September meeting. Mr. Galletta noted he and Mr. Wegele inspected each of the Well Houses and Water Storage Tank Sites on August 11, 2021, going over the Assessment by Crew Engineering. Mr. Galletta stated most of the assessment is generic and all the Sites are in great shape as far as landscaping, and all interiors are clean. Mr. Galletta also stated they found some minor things to be repaired and some items have already been fixed. Mr. Kent inquired if there is a list of the repairs needed for each location. Mr. Wegele noted he will provide the list to all the commissioners. Mr. Galletta noted they are still waiting for the Wastewater Vulnerability Assessment Inspection Report and should have it by the September meeting. Mr. Galletta also reported on raising water and sewer rates at this time as essentials needed for the Authority to perform are going up in cost. Commissioners agree rates should be increased they have delayed doing the increase due to the Covid-19 pandemic. Mr. Galletta will review the suggested increase from last year and will go over it at the September meeting.

### **NEW BUSINESS:**

Mr. Galletta stated he had met with Mr. Wegele to discuss the Authority's 5–30-year water infrastructure upgrade plan. His reasoning to meet with Mr. Wegele was due to the possible money or funds being released under the Water Infrastructure Trust. Mr. Galletta noted that the project on the top of the list was the Ringwood Ave Water Main Replacement Project

which runs from Hamburg Turnpike to Pompton Lakes/Wanaque Border. Mr. Galletta was inquiring whether it would be cost effective to have the project "shovel ready" with the extreme increase in materials. Mr. Wegele stated that Crew Engineering is preparing a proposal on the project and will also be submitting estimated project costs. Mr. Wegele will report at a later date when he receives the proposals from Crew Engineering.
